

A Message from the Society President: A Look Back at 2007

As 2008 gets underway with bitter cold and winter storms, I pause to reflect not only on the busy year the Society had in 2007, but also on the progress we've made and the projects we've completed over the past 20 years. April 2008 will mark the 20-year anniversary of the creation of the Michigan Supreme Court Historical Society, and I'm looking forward to honoring that occasion with you at our Annual Membership Luncheon. But enough looking ahead – let's take a look back at the work we've completed over the past year.

SPECIAL EVENTS

It was business as usual at the Detroit Athletic Club last April, when nearly 150 of our members and friends joined the Society and the Court for the 2007 Annual Membership Luncheon. Professor Paul Carrington, of Duke University School of Law spoke about Thomas M. Cooley and his illustrious career.

In July, the Historical Society assisted in planning a program for the Conference of Chief Justices on Mackinac Island and has since offered materials and support to two other state courts considering the creation of historical societies.

On October 1, the night before the Court's opening session, the executive board of our newly created Advocates Guild hosted the first annual Advocates Guild Dinner in the 6th floor rotunda at the Hall of Justice. There, members of the Advocates Guild enjoyed a reception and

dinner with members of the Court. The following morning, I once again participated in the Court's opening session, reporting to the Court on the Society's recent activities.

ARCHIVES AND ORAL HISTORIES

Over the summer oral historian Judy Christie completed and transcribed the oral history of Erwin Simon. Simon is a former clerk of Justice Henry M. Butzel, and also his son-in-law. The transcript will be made available on our website in 2008.

The Society continues to maintain an inventory of the Court's collection of portraits, which now numbers 87 and to inspect and evaluate them annually.

RESEARCH AND PROJECTS

Thanks in part to a grant from the Michigan Humanities Council, two Michigan educators, Brian Stevens and Cassandra Heos, spent the summer working with our Executive Director to create the Verdict of History lesson plans, which provides high school teachers with lesson plans and mini-moot court activities dealing with some of the Michigan Supreme Court's significant cases. These lesson plans were unveiled at the Center for Civic Education Through Law's annual teacher conference in December. The plans will also be made available at no charge to teachers through other conferences and on-line.

The Significant Cases Committee continues to work with Professor Paul Moreno to complete the second part of the Verdict of History project – publication of a list of

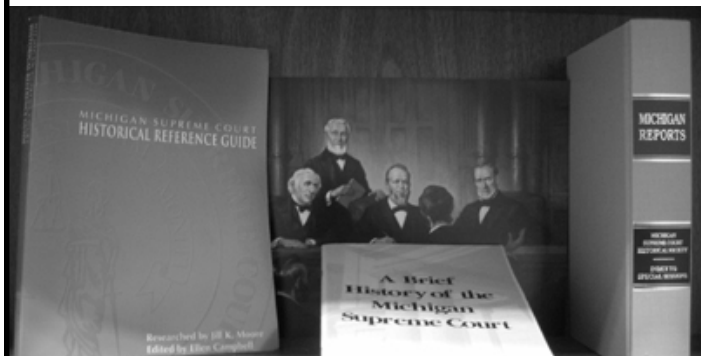
