Dorothy Comstock Riley Legal History Award Honors Both Founder, President for 25th Anniversary

uring the meeting of the Board of Directors immediately preceding the Annual Membership Luncheon in May, the Board of Directors unanimously approved two motions.

The first motion, made by Treasurer Lawrence P. Nolan and seconded by Vice President Charles Rutherford, was to re-name the *Legal History Award* to honor Society founder Dorothy Comstock Riley (MSC 1982–1983, 1985–1997). As Chief Justice, Dorothy Comstock Riley founded the Michigan Supreme Court Historical Society to preserve the court's history and increase public awareness of our legal heritage.

The second motion was to nominate Society President Wallace D. Riley as the fifth recipient of the newly renamed award. Mr. Riley has led the Society as its President since the Society was formed in 1988.

President Riley had been asked to excuse himself from the meeting before discussion of the *Legal History Award*. He was surprised at the Luncheon by the presentation of the award, and in his remarks expressed his wish to share the recognition with the Board of Directors.

- The plaque representing the Dorothy Comstock Riley Legal History Award will be on display in the Hall of Justice.
- Previous winners include Governor John Engler, 2002; Dorothy Comstock Riley, 2003; Rosa Parks (posthumously), 2006; and John W. Reed, 2008.
- The award was created to recognize individuals who have greatly affected Michigan's legal history through support of the Society and its efforts, or through their work in the law.


