## Portrait Rescued From Near Ruin

On Tuesday, October 6, 1998, the Michigan Supreme held their Opening Session in the Old Supreme Court Chambers in the Capitol. At that session, the Society rededicated the portrait of former Justice Nathaniel Bacon. The presentation was made by former Chief Justice Thomas E. Brennan. The following is an excerpt from his remarks:


On June 4th, 1901, Mr. Bacon of St. Louis, Missouri presented to the Michigan Supreme Court a portrait of his father, Nathaniel Bacon, one of the circuit judges who served in the original Supreme Court of this state.

Then Chief Justice Robert Montgomery accepted the painting on behalf of the Court and ordered it hung in this very room. How long it remained on exhibit here, no one really knows. But some time during the intervening 97 years, the portrait was taken down and relegated to dusty storage.

Ultimately, it became the victim, if not of deliberate vandalism, at least of gross indifference to its care and preservation. In 1996, the Executive Director of the Michigan Supreme Court Historical Society, Ellen Campbell, came upon the damaged painting during an inventory of the Court's art works. The canvas was literally shredded in a dozen pieces. The frame was chipped and cracked. But with meticulous professional restoration by Mr. Ken Katz, the portrait has been renewed, and the Society is pleased to be able to return this valuable piece of art to its rightful place of honor. ## THE 1998 COLEMAN INTERN Jill K. Moore

My experience as the 1998 Coleman intern was rewarding in many ways. I am very grateful that the Society provided me with a variety of opportunities to learn about Michigan Supreme Court history, and expand my skills as a historian and writer.

In May, I started my internship duties by helping manage the Society's 10th Anniversary Dinner held in Detroit. I attended the Annual Board Meeting, and met many Society members, including current and former Justices of the Court. I was most pleased and honored to meet Justice Mary S. Coleman, the namesake of my internship program.

In June, I accompanied Executive Director Ellen Campbell to Washington, D.C. for the 1998 Roundtable meeting of Judicial Historical Societies. This was a wonderful opportunity to learn about the business of running a non-profit historical agency.

Upon returning from the conference, I rolled up my sleeves and began working on my research and writing assignment. I gathered biographical information about all the justices of the Michigan Supreme Court — even the Territorial judges, dating back to 1805! I also researched and gathered photos, updated the Index to Special Sessions of the Court, and created a year-by-year Court chart. It was an interesting and very challenging project. And now, my internship project has been organized into a publication titled, The Michigan Supreme Court Historical Reference Guide. It's exciting to know that my research will introduce so many people to Michigan judicial



history. In August I returned to school at St. Mary's College, in Indiana, as a Senior. And looking back at my summer internship, I cannot thank the Society enough for this extraordinary opportunity. I know that I've learned a great deal about the Court, and a great deal about myself.

# REFERENCE GUIDE MAKES HISTORY



he Society's newest publication, The Michigan Supreme Court Historical Historical Reference Guide is a valuable and unique publication. Available to Society members at the end of October, the Reference Guide assembles

information that Colman Intern Jill Moore gathered for her research and writing project this summer.

The Reference Guide is valuable because it contains three sections that analyze Michigan Supreme Court judicial history.

The first section showcases photos of each Justice from 1805 to the present. Along with the photos are thumbnail biographical sketches that give general historical facts about each justice.

The second section is the Index to Special Sessions of the Michigan Supreme Court. This informational table is an index to the *Michigan Reports* which contain every Special Session recorded in the Court. And finally, the third section contains a historical Court chart which shows year-by-year who served on the Bench and in what order of seniority. No matter which section the reader explores, the book provides a fascinating journey through Michigan's state and legal history.

What makes this publication unique is that the information and photos have never been assembled into one publication. So, readers of all ages will enjoy the *Reference Guide*, because it's designed for leisurely reading as well as research.





This is the occasion, if I may beg the Court's indulgence, when men and women of sensibility to historic perspective will find themselves contemplating the threads of human existence that connect this sitting Court to the man whose likeness has been renewed and returned.

Volume 124 of the Michigan Reports, which contains the record of the Bacon portrait presentation ... holds a number of interesting tidbits for us to think about as we connect in this brief moment with our collective past ...

...It is as though this portrait of Bacon had been like that of the fictional Dorean Grey, its visage twisted and corrupted with the passing decades as our state and nation drifted farther and farther from those puritan notions of propriety that Judge Bacon and his contemporaries cherished.

I tender this rehabilitated portrait of Nathaniel Bacon in the hope that its return here in pristine condition might in some way symbolize our own capacity to be renewed and inspire us a common resolve to do whatever we can do to restore popular respect for the dignity of public service.
