Society for inviting me share some of the spotlight on this historic occasion and, of course, I want to thank Bob (Griffin) for his generous comments. Having begun as opponents for election to the Court, we became good friends; not only was Bob a superb lawyer and careful craftsman, he was a consensus builder and among one of the most honorable associates of my professional life. Add Marge's warmth, hospitality, and mother wit, and you'll understand why and how the Griffins enriched our Court.

I have special memories of each of the justices

here, Mary Coleman, of course, as role model, but also for the soundness of her opinions ... Larry Lindemer, a fine, fine justice, Tom Brennan and Jim Ryan, prodigious intellects and mesmerizing orators, each. Dennis Archer's energy, diligence, and genius for solutions ... Charles Levin, whose remarkable creativity kept my little grey cells in constant ferment ... Dorothy, whose scholarship and devotion to the law and the Court I miss every single day. I have been privileged to know you all and to continue to reflect on your contributions to the life of Michigan's law. I need to mention also Mennen Williams. He lives for me as my example of decency, humanity, vision, and humility. In the most difficult decisions of my professional life, I still ask myself, "I wonder what Mennen would have done." Reflecting upon her own career, Justice Boyle closed her remarks with a quote from Oliver Wendell Holmes, "A man must involve himself in the life and passion of his times, or stand in peril of being judged never to have lived at all."

# Conservation Studio Tour DIRECTORS GO ON SITE



Prior to the festivities of the 10th Anniversary Dinner and the Annual Board Meeting, the Society Directors enjoyed an interesting experience that educated them on the art and science of portrait preservation and restoration.

Kenneth Katz, Conservationist and owner of Conservation and Museum Services, in Detroit, toured the Board members through his studio and explained the painstaking process of restoration.

"A restoration artist in our studio can labor over a piece for months to bring it back to its original state of beauty and value." Said Ken.

A veteran in the field of conservation, Ken was trained in Cooperstown, N.Y., and worked for several years at the Detroit Institute of Art honing his craft.

In his presentation, Ken pointed out that repairing artwork takes more knowledge than just knowing how to replicate a certain style of painting. It is a unique blend of art, science, and history. "We have to know the materials these artists used and what chemicals and procedures to use in restoring the piece properly." Ken said.

The Board members asked many questions about time, procedure, materials, and cost in order to understand how to approach the Court's restoration needs.

"Their questions were great," said Ken, "and with continued understanding, the Society can make a thoughtful contribution to Michigan's judicial (art) history."

### A Visit with Justice Marilyn J. Kelly

As the 99th justice of the Michigan Supreme Court, Marilyn J. Kelly follows in a line of judicial service that has a rich history. But Justice Kelly adds much to the Court with her own life story.

Beyond her impressive and lengthy CV, Justice Kelly brings her own style to the Court which reflects her sharp mind, generous spirit, and gentle humor. We asked her to tell us about the development of her legal career and her thoughts about her service on the Bench.

My career developed along a continuum that began early in my schooling. I had the pleasure of being exposed to several good teachers who interested me in foreign languages and cultures. The interest grew into a resolve to study abroad. The year I spent in Paris awakened an awareness in me of the role and importance of government, especially as I

was made to look back on my own country through the eyes of Europeans. That led, on my return home, to my seeking election to the Michigan State Board of Education. During my twelve years there; I learned the extent to which our legal system underpins our government, in fact, our whole way of life. After that, a career in the law seemed to me inevitable.

I greatly enjoyed law school and the practice of law. And still I delight in working with language—criticizing an obscure passage in a statute, marveling at an attorney's clever turn-of-phrase in a pleading, or simply enjoying an extrordinary typographical error.


And being a judge? Without a doubt, it is the best. As another judge put it, "In private practice, lawyers measure success by beating the other side, persuading a jury to acquit someone who is probably guilty, getting a million dollars in a case worth half that much. In this position, I can always do what I think is right. There's nothing to compare with the satisfaction of doing justice, even the smallest case. That's why this is he best job in the world."

JUDICIAL HISTORICAL SOCIETIES EXCHANGE INFORMATION

Twenty-two representatives from judicial historical societies all over the U.S. met in Washington D.C. on Tuesday, June 2, 1998, for the Second Annual Judicial History Round Table at the Supreme Court.

The day long program featured Leon Silverman, of the United States Supreme Court Historical Society, who spoke about board leadership. As president he expressed the importance of effective board recruitment and motivation. Brad Williams of the 9th Circuit discussed the basics of fund raising and the possible sources we may investigate in securing program funding. Judge Jack Hightower of Texas, focused on special events, highlighting the need for soliciting by groups, firms and organizations. In the afternoon, a panel discussion featured Nancy Dobson, (FL), Steve Flanders (2nd Circuit), Paul Lucko (TX), and Kathy Shurtleff (U.S. Supreme Court). Presentations were effective and concise. The assembly discussed publications, newsletters, and educational programs. Everyone agreed that the Roundtable was a successful event!

### State Bar 26th MICHIGAN LEGAL MILESTONE


